FIRST ORDER OF BUSINESS

Call to Order

Mr. Roethke called the meeting to order and read the roll call.

SECOND ORDER OF BUSINESS

Administer Oath to Newly Appointed Officers

Mr. Roethke administered the Oath of Office to Mr. Drackett, and Mr. Drackett replied in the affirmative. Mr. Roethke informed Mr. Drackett that as a CDD Board Supervisor he is entitled to compensation of \$200 per meeting, up to an annual maximum of \$4,800. Mr. Drackett accepted compensation.

Consideration of the Minutes of the Regular Meeting held on November 13, 2014

FIFTH ORDER OF BUSINESS

Consideration of Operation and Maintenance Expenditures for October 2014

On a Motion by Ms. Siegel, seconded by Mr. Drackett, with all in favor, the Board of Supervisors approved the Operation and Maintenance Expenditures for October 2014 (\$128,955.98) for Country Walk Community Development District.

SIXTH ORDER OF BUSINESS

Staff Reports and Updates

A. District Counsel

Mr. Babbar provided a brief update on Sunshine Law and reminded Board members that they should not be using text messages for CDD business. Other forms of social media should be avoided when conducting CDD business as well, such as Facebook and Twitter.

B. District Engineer

Mr. Syrja was not present, but Mr. Roethke updated the Board on the current status of the roadway repairs being completed by SiteMasters. These repairs are completed and we are currently awaiting confirmation of acceptance by the County.

Mr. Roethke also gave the Board an update on the asphalt paving of the roundabout. Azzarelli Paving will be prepping the area during the week of December 29, 2014 and will begin the paving the week of January 5, 2015.

C. Clubhouse Manager Review of Management Report
Mr. Gruhl reviewed the clubhouse management report with the Board. Tomorrow
night at the Clubhouse will be the annual Jingle Mingle, with 50 people planning to
attend. Mr. Gruhl also updated the Board on some pressure washing recently
completed on the sidewalks outside the clubhouse, and some new LED lights

installed inside the clubhouse.

Mr. Roethke informed the Board that the tennis court lighting has been installed, and the lights will be tuned on as soon a Withlacoochee processes the deposit check that was sent this week.

D. District Manager

Mr. Roethke noted that the next meeting would be held on Thursday, January 8, 2015 at 6:00 p.m. at the Country Walk Clubhouse, located at 30400 Country Pointe Blvd., Wesley Chapel, FL 33543.

Mr. Roethke discussed an issue with cars parking on Pasco County right-of-ways and damaging CDD-maintained turf. The Pasco County Sheriff's Office typically will not issue citations for vehicles that are parked in a County right-of-way unless a No Parking sign is visible. This must be a County-installed sign since the Sheriff will not enforce rules from a CDD or HOA sign. Mr. Roethke asked the Board if they would like to have the County install a No Parking sign on the right-of-way next to the conservation area on Sotogrande Loop. The Board requested that Mr. Roethke move forward with this request from the County.
